Report of activities of Dr Ioannis Armakolas

Stavros Costopoulos Research Fellow 2019 – 2020

Dr. Ioannis Armakolas, Assistant professor at the University of Macedonia, Department of Balkan, Slavic and Oriental Studies, continued in his role as Stavros Costopoulos Fellow. Within this framework, he continued this year in his twin role at ELIAMEP as *Head of the South-East Europe Programme* and *Editor in Chief of the scholarly journal 'Southeast European and Black Sea Studies'*, which is published by the distinguished publishing house "Taylor & Francis Group UK (Routledge)" in conjunction with ELIAMEP.

Research Activities:

In his capacity as Head of the South-East Europe Programme of ELIAMEP, Dr. Armakolas continued the design, coordination and implementation of all research and public activities regarding the study of the Balkan region.

In particular, Dr. Armakolas coordinated the preparation and had the overall responsibility for the submission and follow-up on the implementation of five applications for research funding, on behalf of the South-East Europe Programme. The majority of the applications were prepared with partners from other countries and were submitted for funding to the European Commission and other donors.

During the same period, Dr. Armakolas was responsible for the management and implementation of the following five research projects:

- "Deliberating socio economic impact of EU Integration Albanian case and regional experiences", funded by the EC (ongoing)
- "Migration, Integration and Governance Research Center (MIGREC)", funded by EU H2020 (ongoing)
- "Preventing and Addressing Violent Extremism through Community Resilience in the Balkans and the MENA (PAVE)", funded by EU H2020 (ongoing)
- "Confidence Building Measures Between North Macedonia and Greece", funded by the Swedish Ministry of Foreign Affairs (completed)
- "Greece and Albania: Revisiting a tense relationship", funded by the Open Society Foundation for Albania (completed).

The Southeast European and Black Sea Studies Journal:

Regarding the journal "Southeast European and Black Sea Studies", Dr. Ioannis Armakolas remained responsible for all academic and administrative affairs of the journal and coordinated the editorial process. During this period, a number of timely and insightful papers were published by the journal aiming to contribute to the better understanding and awareness related to EU politics and the EU enlargement process in the Western Balkans, as well as the latest political, economic, social and security developments in South-East Europe and the Black Sea region, including Greece, Russia, Cyprus, Turkey and Ukraine.

The journal's impact factor for 2019 was 0.839, a number that reflects the journal's influence on both academic as well as policy circles. During this period, the journal also published a special issue entitled: "Illiberal Politics in Southeast Europe".

The journal remains one of the leading scholarly publications focusing on the specific geographical areas and one of the few prominent journals produced in partnership with an organization outside UK and the US.
