

OUR STORY

In 2015, the financial crisis and the sudden influx of people seeking refuge in Europe put a strain on cross-European relations, particularly between those of Germany and Greece. Our partner organizations identified a need for more constructive exchange between policymakers to mitigate political tensions across Europe. The positive impact produced by the first political dialogue experiences designed by our partners – which brought together politicians from across Europe – highlighted a severe and pervasive gap in dialogue among Europe's policymakers.

The crucial role played by national politicians in shaping the European debate emerged clearly. European politics was being decided as much in the capitals as it was in Brussels. Yet, the effective involvement of national parliaments in the broader European debate remains limited. At the same time, the growing reluctance of one political faction to speak openly to colleagues from across the political and ideological divide, only served to complicate matters further.

The need for better channels for meaningful communication and exchange for national and European politicians to come together and openly discuss matters of European political relevance, was clear.

Our partner organizations, which include think tanks and foundations from across Europe, acting on their mission as non-partisan public policy organizations dedicated to promoting policy debate and cooperation, decided to join forces and launch the Mercator European Dialogue program in 2015.

This political dialogue pilot project has since established itself as Europe's first informal dialogue platform for policymakers across countries and political parties, a permanent platform for policymakers across individual European parliaments to connect in an informal and neutral setting.

In 2021, as the platform grew and brought together new partners and supporters, it was renamed to Open European Dialogue. The project's motto became: "We need to talk!"

That same year it received the recognition of the OECD as a global best-practice for cross-border collaboration and innovation.

Initially launched as a joint initiative between Stiftung Mercator and the German Marshall Fund of the United States, in cooperation with the Barcelona Centre for International Affairs, the Istituto Affari Internazionali in Rome, and the Hellenic Foundation for European and Foreign Policy in Athens. It has since acquired the support of the King Baudouin Foundation, the Robert Bosch Stiftung and the Bertelsmann Stiftung. As of 2023 the Open European Dialogue is coordinated by the non-profit organization APROPOS, which specializes in process design methods for politics, in collaboration with its partners across Europe.

We invite you to join a different kind of political conversation:

FOSTER A SAFE & BRAVE SPACE

The OED is a safe space—feel free to **speak your mind**, you will not be quoted directly. The OED is a brave space—we encourage you to **take risks** and **challenge your own comfort zone.**

ADOPT A SPIRIT OF ENQUIRY

The OED invites you to adopt a spirit of enquiry and engage in more explorative thinking, **spending more time on the diagnosis of a problem**—asking yourself and others "why and how"—rather than jumping to a solution.

EMBRACE & RESPECT DIVERSITY

The OED embraces diversity and will ensure that all political perspectives are treated with respect, and we ask you to do the same. We invite you to proactively **engage with political points of view that are different** from your own and **approach controversy with civility**.

PRACTICE ACTIVE LISTENING

The OED is as much about talking as it is about listening. We ask you to make an effort to **truly listen to your colleagues rather than trying to convince them** of your point of view. Try to listen to understand rather than to counter-react or contradict.

The Annual Dialogue is an opportunity for policymakers from across Europe to come together across party lines and exchange perspectives on today's big-picture political challenges. This unique format allows you, as a member of parliament, to engage in peer-to-peer conversations with your colleagues and gain first-hand insights into the political realities of different member states across Europe. You will be given a chance to explore key policy challenges and best practices, informed by the insights of leading experts, and do so in a protected and trusting environment.

POLICY WORKSHOPS

digging deeper into a specific policy challenge

DURATION 1.5 days PARTICIPANTS 10–15+

TOPIC Pre-identified policy or political challenge FORMAT Flexible, usually involving a mixture of

expert input and participatory exchange

REGISTRATION Necessary

Our policy workshops bring together a selected group of policymakers with a joint interest in deepening their understanding of a specific policy or political challenge. The objective of these workshops is for participants to be able to gather information and exchange political views and best practices. The format of these workshops is flexible as each exchange is carefully designed to reflect the purpose and topic at hand. These workshops can take the form of policy briefings, scenario exercises, fact-finding missions and field-trips, or a more open-agenda format.

Open calls are an opportunity to connect informally and on a regular basis, with other members of parliament (MPs) in the network. The OED will allow you to check in with your peers for one hour every month. We will act as hosts and facilitators, but it is the participants that will bring their own questions and topics to the table. The open-agenda format provides maximum flexibility: no registration is required, topic suggestions can be made spontaneously, and different topics can be discussed by different sub-groups of MPs as the conversation format will adapt to the number of people and topics on the call.

OED120

FORMAT Expert input and guided discussions
REGISTRATION Necessary—limited spots available

The OED120 format allows parliamentarians to receive a concise briefing, ask questions to an expert and discuss with their colleagues a narrowly defined topic during a 120-minute video call. The OED provides professional facilitation to extract the most value out of the discussions. Policymakers get the chance to share their own perspectives with their colleagues, while having topic expertise on hand for questions and clarifications. Topics are chosen as they emerge through the network as ripe for more in-depth discussion. Additionally, members of the network, or OED researchers and experts, can suggest topics. Network members can initiate these calls, as well as volunteer their own expertise on a topic of their choosing.

Following the steps of the design sprint methodology, a group of committed members of parliament (MPs) tackles one topic, from problem exploration to working out a feasible way forward, with a limited number of highly focused meetings. This approach is perfectly suited for groups that have a rough idea of a specific problem area they are thoroughly invested in addressing and need a guided process through which to formulate a common and impactful response. This approach is light on expert input and relies on MPs' initiative and ongoing contribution to pull through from start to finish.
