

MESSAGE FROM THE DIRECTOR GENERAL

George Pagoulatos



The year 2020 will go down in historical memory as the year of the global pandemic. ELIAMEP was not alone in discovering how formidably adaptable humans and institutions are in the face of unexpected adversity, and how a universal crisis can trigger reactions of solidarity - indeed, even open up new opportunities. For, despite the hardships, 2020 turned out to be a remarkably productive and successful year for ELIAMEP.

As the restrictions and lockdown measures became the new normal and a number of ELIAMEP's planned activities had to be postponed, we adjusted rapidly and moved all our activities online. This would not have been possible without the professionalism and dedication of our staff. We were among the first Greek organisations to launch our public discussions online, with a Directors panel with Bruegel and the European Policy Centre on the implications of COVID-19 for the Eurozone. Soon after that, we participated in a similar panel with another five major European think tanks (Carnegie Europe, CIDOB, ECFR Berlin, IAI, Political Capital Hungary). A number of both Greek and international online panel discussions followed (a total of 68 public events in 2020) on topics ranging from the new US Presidency and transatlantic relations to energy security in the Mediterranean, and from the challenge of political Islam to the implications of the #MeToo movement.

All our panels can now be accessed on ELIAMEP's Official [YouTube channel](#), which was launched and consolidated in 2020 and which we encourage you to subscribe to. This was also

the year in which our series of weekly podcasts was launched, with 29 podcasts produced for 2020, all of them managed by Odin Linardatou, our Head of Communications .

In 2020, ELIAMEP published a grand total of 84 policy papers, working papers and policy briefs, the highest annual output in our 33-year history.

ELIAMEP's publications are now included in the electronic libraries and compendiums of the main EU institutions (the European Commission, Council and European Parliament).

2020 was a very productive year in terms of research proposals and projects obtained: there were 20 projects running during the year, with 10 new projects won. In 2020, ELIAMEP was one of just two Greek institutions to obtain a European Research Council (ERC) grant for research in the humanities, for the HOMEACROSS project led by Dr Kalliopi Amygdalou. We take particular pride in the fact that excellent young researchers from Greece and abroad choose ELIAMEP as their host institution for high-quality research proposals under the ERC, Marie Curie or Horizon 2020 programmes.

Three new programme areas were launched in 2020: The programme on Turkey has already established itself as an international reference point for systematic analysis of Turkey, its domestic dynamics and external surrounding. The programme on Sustainability has put ELIAMEP at the heart of the important policy debate on the various implications of climate change. And the programme on the Mediterranean has set out to promote understanding and nurture cooperation in a region characterized by high interdependence and considerable untapped creative potential.

MESSAGE FROM THE DIRECTOR GENERAL

In December 2020, we published the ELIAMEP [Outlook for 2021](#), bringing together predictions made by our senior researchers and programme heads in relation to a number of areas and sectors of interest to ELIAMEP. The Outlook was featured in a special 8-page insert in the Greek newspaper *Ta Nea*, and was widely read in Brussels and other world capitals. Throughout 2020, several newspaper special features have presented the work of ELIAMEP. Indeed, hardly a day goes by without articles by or interviews with ELIAMEP researchers, fellows and advisers in the Greek press. ELIAMEP has also maintained its presence in the international media, where it remains a steady source of reliable analysis, especially when Greece finds itself the focus of international attention. This regular presence on the part of its experts, coupled with their participation on panels and at conferences

hosted by other institutions, makes ELIAMEP a highly visible reference point in both national and European public debates.

The experience of 2020 has made us optimistic about the combined promise of science, reason and good governance in combatting the pandemic. Looking ahead to 2021, we are eager to continue with another successful year in which we renew our commitment to contributing solid fact-based analysis and dispassionate arguments that enrich the national, European and global intellectual and public policy conversations.





General Description

The institutional, political and economic dimensions of European integration have always been a key area of interest for ELIAMEP. The events and programmes of the previous year focused on the impact of the COVID-19 pandemic on the EU and its member-states with particular emphasis laid on the European response to yet another crisis. At the same time, the debate on the Future of Europe has been identified as a priority for ELIAMEP's European programme given the warming up of the debate. Relevant communication and dissemination activities have been monitored and the first proposals have been analysed, given ELIAMEP's intention to have an active role in the envisaged national and European deliberation.

Overview of Year


➡ We continued our work in connecting European policymakers across parties and nations, providing a unique space for dialogue and promoting innovative political conversations, within the framework of the Open European Dialogue project (formerly known as the Mercator European Dialogue).

➡ We carried out research as part of the DEMOS project, on the populist ideology and populist themes of Greek Political parties, complementing earlier research on populist parties in contemporary Europe. The research included: survey and analysis of political party programmes and government measures; field research on populist challenges against vulnerable groups; and research on populist government policies with focus on economic policies and labor market policies during Greece's long economic crisis.

➡ As part of the EU3D project, we collected and coded debates that took place in the Greek Parliament in 2015-2020 on the Eurozone crisis, the 2015 migration crisis, and on issues related to the breakout of the pandemic of COVID-19. We studied the effects that crises as external or internal differentiating shocks have on evolving patterns of EU governance and on further integration. Additionally, we collected proposals on the Future of Europe put forth by Greek political parties, the government and various institutes and think tanks.

➡ We carried out with the implementation of ELIAMEP's organisational Gender Equality Plan (GEP) and monitoring of its results in the frame of the TARGET project. One of the key accomplishments was the establishment of a data collection system that enables us to systematically record and maintain gender disaggregated data on our human resources and activities.

➡ In the COMPACT project, we focused on the preparation of academic publications and the organization and participation of the research team in dissemination and awareness raising events.



Success Stories

➡ Publication of a manual on how universities and research organisations can develop institutional Gender Equality Plans (GEPs) – the 1st comprehensive methodology and set of guidelines in this area in Greek, in the frame of the TARGET project. This manual provides a valuable tool to Greek research and higher education institutions that are currently in the process of developing GEPs. The manual was widely distributed to all Greek universities and to many research institutes across Greece.







General Description

In the contemporary international environment, global, international, regional and national security are closely intertwined and affected by various trends and drivers. In an effort to explore and better understand global and regional security dynamics, especially in Greece's southeastern and northern neighborhoods, regions of increased fluidity and instability, ELIAMEP has launched several projects on issues such as: the EU role in the Western Balkans and the Mediterranean, relations between the West and Russia, transatlantic relations, conflict resolution in the Mediterranean and the Middle East, energy, Black Sea-related developments, international terrorism, and the prevention of radicalisation. Key issues for Greek foreign and security policy, like relations with Turkey, the Cyprus issue, and relations with North Macedonia, retain high priority in ELIAMEP's policy-oriented research agenda.

Overview of Year

➔ Researchers and advisors of the Programme on Security and Foreign Policy have provided analyses to national and international newspapers and media and were interviewed by diverse national, European and global media networks, including Al Jazeera, Le Monde, New York Times, Al Monitor, Euronews, BBC News, CNN, etc.

➔ More than two-dozen policy papers, policy briefs, books and edited volumes have been published on line.

➔ Organisation of about 20 online public discussions, webinars and round-table discussions on issues related to, among others, current and future security threats in the Mediterranean; challenges of the post COVID-19 era; cyber security, energy security and climate change; the next day in the Eastern Mediterranean after the US elections; the EU, Turkey and Greece relations and the migration challenge; Greek-Israeli relations; political Islam and democracy; geopolitics and economy in the Eastern Mediterranean.





General Description

Acknowledging early on the importance and significance of migration, the Migration research team has developed innovative research projects in response to new and old challenges of contemporary human mobility. ELIAMEP's team provides research, analysis, and evaluation of migration and refugee policies at national and European level. It also seeks to formulate pragmatic recommendations to the challenges and opportunities that migration brings for Greece and the European Union.

Overview of Year

In 2020, our work focused on the European asylum and integration policies. The pandemic impacted in an unprecedented manner the access to territory, asylum processing and integration of asylum seekers. We analysed the European Pact on Migration and Asylum, discussed the impact of the Greek policies on migrant reception and integration and sought to highlight the role of the pandemic as regards access to social and legal rights for migrants and asylum seekers. Research in the framework of the NOVAMIGRA project zoomed in on hospitality as a critical value in the “refugee crisis” reflected in the work of civil society. EWSI Greece was involved in the research study 'What measures are in place to ensure the long-term integration of migrants and refugees in Europe?', looking at policies and measures across various areas of life that aim to promote the long-term integration of beneficiaries of international protection (BIPs) and other third-country nationals (TCNs). We concluded our research on EU-Turkey relations on migration with the VIADUCT research award. ELIAMEP became a member of a new independent interdisciplinary research network on migration and diversity , Euro-Mediterranean Research Network on Migration (EuroMedMig), in an effort to re-orient part of the research towards the Mediterranean basin.



General Description

The South-East Europe Programme of ELIAMEP was set up in 2011. Research and policy analysis on Balkan affairs has a long tradition in ELIAMEP going back to its early days in 1988. The Programme intends to follow that legacy of high-quality scholarly and policy work. The South-East Europe Programme publishes policy analyses and research findings through the standard publishing outlets of ELIAMEP. It also reaches wider audiences by publishing short articles and op-eds in prominent Greek and international media and its news are communicated to several thousand subscribers through the mailing lists of ELIAMEP and the South-East Europe Programme as well as through social media. Last but not least, the South-East Europe Programme is associated with the academic journal Southeast European and Black Sea Studies, published by ELIAMEP in partnership with Taylor & Francis.

Overview of Year

2020 has been a very challenging and at the same time very demanding year for the SEE Programme. The restrictions imposed due to the COVID-19 Pandemic and the implementation of two EU funded Horizon 2020 projects dominated the year. A great number of activities and events scheduled for 2020 had to be cancelled, postponed or rescheduled because of the COVID-19 pandemic. Despite the hardships that we confronted, the SEE Programme team managed to adapt and carry out all its work in the most efficient way. Online meetings and webinars have entered our lives and we embraced this new modus operandi. The methodology seminars in the context of MIGREC have

been delivered with great success to the post graduate students and academic staff of the University of Belgrade in the fall, not to mention the report on ‘Mapping of Migration Related Research and Policy Development in the Western Balkan’ which was also featured in the April 2021 issue of the EU Council Thin Tank Review. The ELIAMEP team was perfectly coordinated with the other international PAVE partners through online meetings and webinars. Finally at the end of the year, in December, the presentation of the report on the connectivity between Greece and North – Macedonia, although it was held on line, became a smashing success with more than 100 participants who engaged into a lively and active conversation. The manner in which our team tackled these new challenges proved that the SEE Programme is a well – structured, highly motivated and dynamic team.



General Description

ELIAMEP's Turkey Programme was established in 2020 and aims to promote consistent, reliable and research-substantiated information and analysis of Turkey's domestic political and foreign policy developments, its relations with Greece, the European Union, the United States, Russia and the emerging powers. Its key objectives include the observation of actors and policies, domestic and foreign, in Turkey that influence its relationship with Greece, its other neighbors, the European Union and other regional and global actors and the dissemination of reliable information and informed, solution-oriented analysis on Turkish politics, as well as the promotion of expert and public dialogue on Turkey and the production of high-quality research and policy analysis publications. It aspires to establish ELIAMEP as a regional and European point of reference in policy debates about Turkey, spanning from Greek-Turkish bilateral issues to topics of regional security, European and transatlantic interest, by promoting closer relations, synergies, networking with leading think tanks and researchers in Turkey, Europe and North America, and aiming to nurture a generation of young researchers on Turkey.

Overview of Year

ELIAMEP's Turkey Programme commenced its activities in 2020 with the establishment of its research team and Advisory Board and developed a consistent and rich production of online discussions, policy papers and academic articles, as well as a steady and respected presence in prominent print and electronic media outlets, through interviews given and opinion articles written by members of the Programme Team on Turkey's domestic and foreign policy developments, regional developments and security questions. As part of the Project's overall aims, efforts were made to develop collaborations with leading think-tanks, resulting in joint webinars among other outcomes.

General Description

The Mediterranean is Europe's frontline to Africa and the Middle East, but it is poorly connected and its potential remains largely untapped. Further, the region is defined by contrasts. The EU Med enjoys good governance and rule of law, whereas several other Mediterranean countries do not. This hinders progress, peace and prosperity; it erodes security and undermines trade and investment; it fuels conflict, and promotes illegal migration. ELIAMEP's Mediterranean Programme is unique in that it seeks to understand these challenges by approaching the Mediterranean through the lens of connectivity. ELIAMEP's Mediterranean Programme focuses on the following thematics: Mediterranean connectivity; climate change and the relevance of the Mediterranean to the success of the EU Green Deal; gender, security and peace; trade, global and regional value chains; Mediterranean regional security and its relevance to Brussels, Washington, and Beijing.



General Description

The great global challenges of recent years, from climate change and environmental pollution to pandemics and economic crises, have made it clear that the well-being of nations and people requires a new approach, beyond the age-old preoccupation with diplomacy and security. Sustainable development has become a central frame of reference for issues related to the environment, the economy and society. International initiatives such as the UN Sustainable Development Goals (SDGs) and the European Green Deal are contractual obligations of Greece but at the same time touch on real issues that need to be addressed. 

General Description

Following Greece's exit from the adjustment programmes and the consolidation of economic recovery in Greece and the EU, ELIAMEP focuses on the dynamics of the Greek and European economy and the identification and analysis of the most important challenges facing them in securing strong and sustainable economic growth. The Greek and European Economy Observatory serves this objective by promoting research, the constructive exchange of views and the formulation of policy proposals. The Greek and European Economy Observatory continues the work of the Crisis Observatory, an ELIAMEP initiative, created in 2013 with the support of the "Stavros Niarchos Foundation". The complete material of the Crisis Observatory (2013-2019) is maintained in its previous website <http://crisisobs.gr/en>, as an open access archive for informative and research purposes.

Overview of Year

During 2020, the work of the Greek and European Economy Observatory was unavoidably affected by the pandemic. The Observatory focused on the economic repercussions of the pandemic in Greece, Europe and the world. This change in focus affected both the publications of the Observatory but also its function as a provider of information and expert knowledge to the public. Regarding its publications, most of the work presented by the Observatory's research fellows and associates was related to the pandemic, with a special focus on the deliberations that took place in the EU about the appropriate economic policy response, which resulted in the historic decision to establish the Next Generation EU mechanism. In terms of informing the public about the economic implications of the pandemic, the Observatory launched a weekly newsletter, which contained all the important policy developments regarding the pandemic, as well as summaries of a selection of some the best economic analyses published internationally about the impact of the pandemic on the economy. After the publication of 17 weekly issues, from September, the newsletter was replaced by a new permanent weekly column, called "In Focus", which provides concise and focused analyses of topical economic developments with the use of a graph. Finally, in 2020, the Observatory continued its research programme, launching a new project, supported by the EEA Grants, on "Youth Employment and Gender Equality: Mobilizing human capital for sustainable growth in Greece". The project's theme is crucial for Greece, in its effort to relaunch its economy and exploit its full potential, following a decade of crises.







RESEARCH CHAIRS

Chair of the A. G. Leventis Foundation

Since October 2017, the A.G. Leventis Foundation is funding a Research Chair at ELIAMEP. In its first three years of operation, the Chair has supported annual studies on issues of European Political Economy of Greek interest. The studies have been prepared by researchers/academics of recognised value, and have been presented at public events, where they were commented on by well-known academics, researchers and policy makers. In addition, part of the funding has supported a junior researcher position. The junior researchers that have filled this position have published working papers which bear the logo of the sponsor (A.G. Leventis Foundation) and have assisted the team of researchers working on the annual studies.



Starting from the academic year 2020-21, the A.G. Leventis Research Chair supports a postdoctoral research position in the field of Greek and/or European political economy.

The program lasts one year and is renewed every year.

Flagship Activities

During the Academic Year 2019 – 2020, the Chair funded a study entitled “[Openness, Exports and Wage Environment in the Greek Economy](#)”, assigned to Professors Margarita Katsimi, Sarantis Kalivitis and Thomas Moutos, at the Department of International and European Economic Studies, Athens University of Business and Economics.


During the Academic Year 2020 – 2021, according to the Chair’s new mode of operation, a Postdoctoral Researcher was selected following a public call of interest. Dr. Apostolos Fasianos, the selected chair holder, explores the relationship between monetary policy and income inequality using a cross-country panel approach.

RESEARCH CHAIRS

Stavros Costopoulos Research Fellowship

This research fellowship was created in 2007, with support from the J.F.Costopoulos Foundation. Through its establishment, ELIAMEP sought to upgrade its research on traditional foreign policy issues, such as the European integration, Greek-Turkish relations, developments in the Middle East and the Balkans or transatlantic relations. At the same time, this fellowship furthered ELIAMEP's efforts to create a supportive environment for the development of Greece's research potential.

The fellowship was held by Dr. Ioannis Armakolas, until August 2020. Since September 2020, the fellowship is held by Assistant Prof. Dimitris Katsikas.



Flagship Activities

During the Academic Year 2019 – 2020 , Dr. Ioannis Armakolas continued his twin role at ELIAMEP as Head of the South-East Europe Programme and Editor-in-Chief of the scholarly journal ‘Southeast European and Black Sea Studies’. He continued the design, coordination and implementation of all research and public activities regarding the study of the Balkan region, and was responsible for the management and implementation of the five research projects.

In September 2020, Assistant Prof. Dimitris Katsikas took over as Stavros Costopoulos Research Fellow, in his capacity as ELIAMEP Senior Research Fellow and Head of the Greek and European Economy Observatory. He continued with the design, coordination, and implementation of all the research and public activities related to the study of the dynamic of, as well as the challenges facing, the Greek and European economy. During this period, he completed his research for the EU-funded, Horizon 2020 ‘DEMOS’ research project, and was responsible for the management and implementation of the research project ‘Youth Employment and Gender Equality: Mobilizing human capital for sustainable growth in Greece’, funded by the EEA Grants Bilateral Fund. He published 21 posts on the Greek and European Economy in the ELIAMEP ‘In focus’ series, as well as 7 articles in the press, 1 ELIAMEP podcast, and chapters in 4 publications.


General Description of EDIC ELIAMEP

The Europe Direct Information Center (EDIC) hosted at the Hellenic Foundation for European and Foreign Policy (ELIAMEP) is the citizens' starting point for finding information about the EU; how it works, its finances and its actions. EDIC ELIAMEP is part of a network of similar centres across the European Union.


The main objective of Europe Direct ELIAMEP is to help citizens with their questions about their EU rights, funding and any other European matter that they are interested in; to provide them with EU documents and publications; to refer them to other information sources; and to provide them with contact details for relevant organizations. Furthermore, Europe Direct ELIAMEP informs the Greek citizens on current European issues through its website, social media (Facebook, Twitter, Instagram), articles, interviews and events.

Overview of Year

Although 2020 was a challenging year due to the COVID-19 pandemic and related restrictions, our engagement with the public not only continued but it further expanded. Also, the Centre diverted all its efforts to the digital milieu:



1) All of our events were organised digitally, by using online platforms, such as ZOOM and Webex.






Organisation of a Citizens' Dialogue with the Vice-President of the European Commission, Mr. Margaritis Schoinas. Citizens from all over Greece had the opportunity to ask the Vice President questions about the European Union, thus expanding our traditional audience, in comparison to physical events .

2) Turning the crisis into an opportunity: Using online tools

Our Centre had the chance to experiment with different types of virtual events and ideas, in order to keep on engaging with the citizens of Attica, and at the same time, trying to find ways to inform and entertain them.



An example of this venture is the creation and organization of online treasure hunts. We used this online tool to either replace our traditional information seminars to schools, such as the example at the 4th Primary School of Naplio, or to enhance them, such as our participation in the 2020 Ecotivity Summer School. We were aware that citizens, particularly young people, had spent millions upon millions of hours in front of a computer, attending lessons/lectures at schools/universities and their attention span is limited by these compulsory activities. An online treasure hunt can work as both an educational and entertaining tool.



“Learning about the EU: A Complete Guide to staying home!”. Our Centre created an online, easily accessible guide with numerous activities and opportunities for all citizens to learn about the EU, while staying at home and having fun, like quizzes, virtual visits to European museums, taking part in EU initiatives, such as the “Learning Corner” etc. The Guide is still operational and will continue to be updated for as long as the pandemic lasts. 3) Entering the Digital Age: EDIC ELIAMEP’s Infographics and Videos

EDIC ELIAMEP expanded its YouTube channel that was created the previous year and added informational videos about key EU processes, such as the priorities of the Presidencies of the Council of the EU, fun videos about the available EU applications for smartphones and online live events, such as the Citizens’ Dialogue with VP Margaritis Schinas.

8 Actions taken by the EU to Combat COVID-19

EUROPE DIRECT INFORMATION CENTER—ELIAMEP

Our Centre perceived that the amount of information coming from EU institutions concerning the fight against the pandemic was ever growing and it became very difficult to keep up with EU developments on the matter, especially when news articles involved complex initiatives, like the “Next Generation EU”, “EU4Health”, “RescEU” etc. Our Centre decided to create dedicated infographics in order to focus the attention of the citizens to the main initiatives and to key information that these entail. Our endeavour was a success, since not only posts with these infographics gathered more reactions on social media, but other Europe Direct Information Centres in Greece used them to inform their citizens.

Last but not least, one of our main concerns was to provide citizens with an alternative to our walk-in centre, taking into consideration the COVID-19 restrictions. Our solution was to enable citizens to contact us, though a live chat application that is easily available on our website.



Social Media Content: Declarations from EU Officials concerning Greece and the EU.



EVENTS

As part of its outreach strategy, ELIAMEP undertakes various kinds of information and awareness-raising activities, which include the organisation of all types and sizes of events, such as high-level conferences, trainings (both face-to-face and online), international seminars, round-table discussions and open dialogues. In March 2020, the outbreak of the COVID-19 pandemic led to a rapid adjustment to the new reality. As a response to the current crisis ELIAMEP launched its series of online public discussions and webinars.

In 2020 ELIAMEP successfully organised **68 events**, a selection of which is presented in the table below. Specifically, within the first quarter of the year, ELIAMEP organised **6 in-person conferences** and **5 in-person seminars and roundtable discussions**.

Following the outbreak of the pandemic, ELIAMEP held **29 webinars** and **28 online public discussions**, which were broadcast live on the Foundation's website and its official accounts on social media (Facebook and YouTube). 

[Refugees at the gate of Europe](#) (22/04/2020)

The recent crisis in Evros brought back to the fore the issue of immigration and Turkey's role in its instrumentalisation. The EU-Turkey Statement has not had the expected outcomes. Rather it showed that prevention policies and the outsourcing of migration management strengthens transit countries such as Turkey, without resulting in a steady reduction in flows. Greece remains a country that bears a disproportionate burden of responsibility due to its geographical location. At the same time, it has delayed in the planning of a holistic immigration policy, which should aim, among other things, to ensure human living conditions, substantial access to asylum and result in the integration of those who will remain in the country. COVID-19 will bring about significant socioeconomic changes globally as well as impact human rights. Practices of the past do not necessarily fit for the new reality and this is the biggest challenge for Greece and the EU; a willingness to


move forward by investing on migration within Europe and beyond. It will not be easy, and it will come at a high financial (and likely political) cost. The pandemic makes any long-term commitments seem impossible, however the alternative scenario, of deterrence and outsourcing is already proving insufficient. Balancing the scales is a challenge which the EU cannot afford to lose.

Lately, the relationship between Turkey and the European Union has taken a turn to the worse, due in particular to military threats related to the issue of maritime boundaries. More than the substance of this litigation, the narrative used by the Turkish leadership seems bound to prevent its quick resolution.





FINANCIAL OVERVIEW

ELIAMEP is mainly financed by the implementation of competitive research programmes (primarily funded by the European Commission and secondarily by other institutions and organisations), as well as the private sector. ELIAMEP maintains a well-established and extensive international cooperation network with research institutions and think tanks abroad. ELIAMEP does not rely on government funding since 2008. Before 2008, government funding had never exceeded 25-30% of the overall ELIAMEP budget, and was mainly related to the implementation of specific programmes and studies.
